

(57) Abstract: Various techniques are described herein for controlling autonomous and semi-autonomous motorized weapons systems. In various embodiments, semi-autonomous motorized weapons systems may perform automated target identification, selection and prioritizatio n techniques. Dynamic target tracking may be performed, for both primary and secondary targets, in cases of stationary and moving targets and weapon systems. A motorized weapon system then may be actuated automatically toward a firing solution target point, during which the operator-controlled firing mechanism may be enabled or disabled based on the projected point of impact of the weapon in comparison to a determined boundary area associated with the target.
