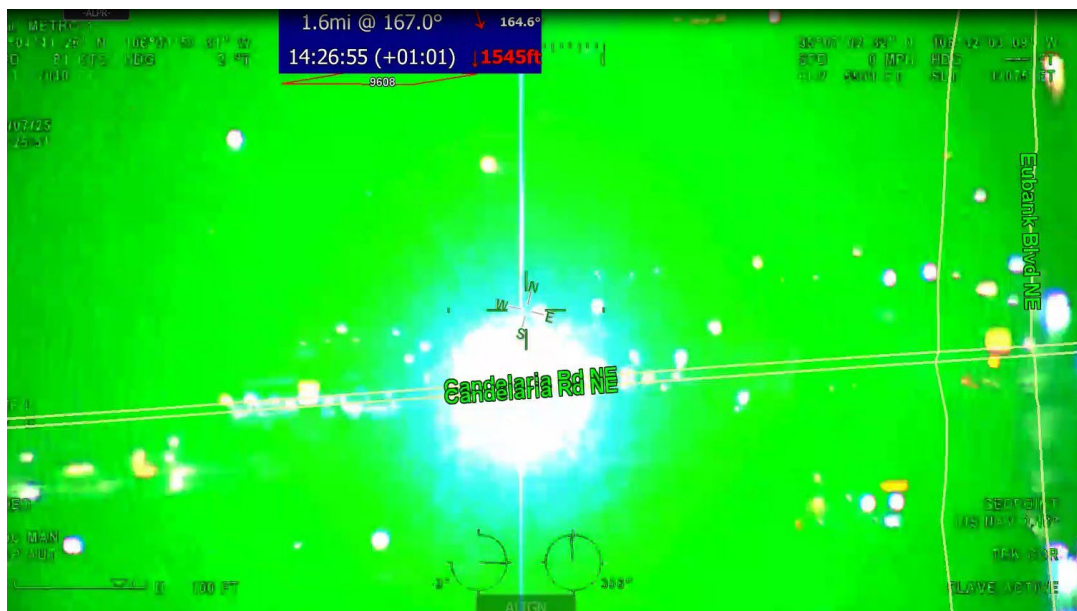
MOTION TO DETAIN DEFENDANT PENDING TRIAL

The United States respectfully requests a detention hearing be held pursuant to 18 U.S.C. § 3142(f)(2)(A) because of the “serious risk that [Defendant Jorge Pinon Armendariz] will flee.” The United States further requests the Court detain Armendariz pending trial pursuant to 18 U.S.C. § 3142(e)(1) because no conditions of release will reasonably assure his appearance given that he committed the present federal offense while on state pretrial release and given Armendariz’s extensive history of absconding and failing to appear for state-court proceedings and to comply with state-court conditions of release.

FACTS

I. Armendariz repeatedly struck BCSO’s Metro 1 helicopter with a laser beam.

On the evening of October 7, 2025, a Bernalillo County Sheriff’s Office (“BCSO”) Pilot and Deputy were flying in the Metro 1 helicopter assisting ground officers with an operation when the Pilot was struck in the eye by a green laser beam. Metro 1 changed course to attempt to identify the source of the laser beam. By zooming in with the helicopter’s on-board camera, Metro 1 could see the laser beam coming from a car in the McDonald’s drive thru on Candelaria and Eubank in Albuquerque, New Mexico.



The laser beam initially struck the cockpit of the helicopter at least three times, refracting off the glass and into the eyes of Metro 1's crew. The laser beam then disappeared. Unable to identify a suspect, Metro 1 resumed assisting ground deputies with their operation.

Not long after the initial strike, Metro 1 was again hit by the green laser beam. Metro 1 initially flew away from the laser, but the beam continued to find the cockpit. The helicopter then flew towards the laser beam, trying to identify its source. The Pilot and Deputy aboard Metro 1 continued to be struck by the green laser beam at least a dozen times. Metro 1's camera showed the beam coming from outside a house not far from the McDonald's.

Metro 1's crew identified the house address, and ground personnel arrived there soon after. On arrival, BSCO deputies on the ground observed a man and woman standing outside the house. The man quickly went inside and then fled. BSCO later learned the man's name: Jorge Pinon

Armendariz. BSCO also identified Armendariz as the person who had repeatedly struck Metro 1 with a green laser beam that night.²

DISCUSSION

I. Armendariz’s history of absconding, committing a federal crime while on release, and failing to appear shows no condition of release will reasonably assure his appearance.

The United States respectfully submits that no condition or combination of conditions of release will reasonably assure Armendariz’s appearance in this federal case given his history of fleeing, absconding from state supervision, committing the present offense while on state pretrial release, and failing to appear for state-court hearings.

The Court must order Armendariz detained pending trial if it finds “that no condition or combination of conditions will reasonably assure the appearance of [Armendariz] as required.”

18 U.S.C. § 3142(e)(1). To make this finding, the Court considers a few factors:

- (1) **the nature and circumstances of the offense charged**, including whether the offense is a crime of violence, a violation of section 1591, a Federal crime of terrorism, or involves a minor victim or a controlled substance, firearm, explosive, or destructive device;
- (2) **the weight of the evidence against the person;**
- (3) **the history and characteristics of the person**, including—
 - (A) the person’s character, physical and mental condition, family ties, employment, financial resources, length of residence in the community, community ties, past conduct, history relating to drug or alcohol abuse, criminal history, and record concerning appearance at court proceedings; **and**

² Laser strikes on aircrafts pose a significant public safety threat. According to publicly available data put out by the Federal Aviation Administration (“FAA”), New Mexico had the second highest per capita incidents of laser strikes on aircrafts in the country in 2024 and 2025, second only to Washington, D.C. <https://www.faa.gov/about/initiatives/lasers>. According to the FAA, “Aiming a laser at an aircraft is a serious safety risk and violates federal law. Many high-powered lasers can completely incapacitate pilots who are trying to fly safely to their destinations and may be carrying hundreds of passengers.” <https://www.faa.gov/about/initiatives/lasers/hazards>. Because of this serious safety risk, President Obama signed into law the FAA Modernization and Reformation Act of 2012, establishing the federal criminal offense of aiming a laser pointer at an aircraft in violation of 18 U.S.C. § 39A.

(B) whether, at the time of the current offense or arrest, the person was on probation, on parole, or on other release pending trial, sentencing, appeal, or completion of sentence for an offense under Federal, State, or local law; **and**

(4) the nature and seriousness of the danger to any person or the community that would be posed by the person's release.

18 U.S.C. § 3142(g) (bold added). The United States must only prove risk of flight “by a preponderance of the evidence.” *United States v. Cisneros*, 328 F.3d 610, 616 (10th Cir. 2003).

Here, Armendariz's history of absconding and noncompliance is extensive. At the time of the laser strikes, Armendariz had an active state warrant for violating conditions of pretrial release in his State-of-New-Mexico case for receiving or transferring a stolen motor vehicle and possession of a controlled substance. Armendariz had been released on pretrial conditions in this case on August 5, 2025. **Govt. Exh. 1 at 1–2.**³ He then violated his conditions and absconded from state supervision, and a state arrest warrant issued on August 28, 2025. **Id. at 5.** Armendariz had already absconded when he repeatedly struck Metro 1 with a laser beam on October 7, 2025, and then fled the scene. **See id. at 6.** On December 3, 2025, a federal grand jury returned an indictment charging Armendariz with aiming a laser pointer at an aircraft in violation of 18 U.S.C. § 39A, **doc. 2**, and a federal arrest warrant issued, **doc. 3**. Armendariz evaded arrest on state and federal warrants for seven months; he was finally arrested on April 2, 2026, on the state warrant. **Govt. Exh. 1 at 6.** The fact that Armendariz committed the present offense while on state conditions of pretrial release counsels for his detention. *See* § 3142(g)(3)(B) (directing courts to consider “whether, at the time of the current offense or arrest, the person was on probation, on parole, or on

³ **Government Exhibit 1** consists of highlighted copies of publicly available New Mexico state-court filings as well as screenshots of publicly available state-court dockets. The United States highlighted these documents for the Court's and defense counsel's convenience. The United States requests that the Court take judicial notice of these documents and dockets. Fed. R. Evid. 201 (“The court may judicially notice a fact that is not subject to reasonable dispute because it: **(1)** is generally known within the trial court's territorial jurisdiction; or **(2)** can be accurately and readily determined from sources whose accuracy cannot reasonably be questioned.”). The United States further requests that the Court take judicial notice of the criminal history detailed in Armendariz's forthcoming Pretrial Services Report.

other release pending trial, sentencing, appeal, or completion of sentence for an offense under Federal, State, or local law.”).

Armendariz’s serious risk of flight is further demonstrated by his long history of failing to comply with conditions of release and to show up for state-court proceedings. For instance, in 2021 Armendariz was charged by the State of New Mexico with driving while his license was revoked (DWI related), improper display of registration plate, and no proof of insurance. *Id.* at 7–8. Armendariz was released on his own recognizance. *Id.* at 9. But Armendariz then repeatedly failed to appear. In fact, during the pendency of this state case, the judge issued a total of nine different warrants for his arrest. *Id.* at 12–22. Another example of Armendariz’s failure to comply occurred in 2010 after he pled guilty to state felony Aggravated DWI (4th offense). He then failed to appear for his sentencing hearing, and the court issued a bench warrant. *Id.* at 23. This warrant remained active for nearly eight months until Armendariz was finally arrested. *Id.* at 24.

The United States highlights a few key examples of Armendariz’s noncompliance to establish his serious risk of flight, but the forthcoming Pretrial Services Report may reveal even more noncompliance by Armendariz in other state-court proceedings.

CONCLUSION

Based on Armendariz’s history of absconding, committing a new federal crime while on state pretrial release, and failing to comply with state-court orders, the United States respectfully requests the Court detain Armendariz pending trial pursuant to 18 U.S.C. § 3142(e)(1) because no condition or combination of conditions of release will reasonably assure his appearance.

ORDER SETTING CONDITIONS OF RELEASE

Finding of Probable Cause

I find that there is a written showing of probable cause to believe that a crime has been committed and that the above named defendant committed it.

Failure to Make Showing of Probable Cause

I find that probable cause has not been shown that a crime has been committed and that the above named defendant committed it. IT IS THEREFORE ORDERED that the defendant:
be released on personal recognizance;
appear before the Court as directed; and
not violate any federal, state or local criminal law.

The Court FINDS the following factors support the Court's decision regarding the bond and conditions set:



The District Attorney of Chaves County, State of New Mexico, states that on or about the dates listed below, the above-named Defendant did commit the crimes of:

Count 1: **Driving While License Revoked (DWI Related)**, (6526), on or about November 09, 2021, the above-named defendant drove a motor vehicle on a public highway of this state at a time when his privilege to do so was revoked and knew or should have known that his license was revoked, and such revocation was due to a charge of Driving While Under the Influence or a violation of the Implied Consent Act, a specific penalty misdemeanor, contrary to NMSA 1978, Section 66-5-39.1 (2013).

Count 2: **Improper Display of Registration Plate**, (7297), on or about November 09, 2021, the above-named defendant operated a vehicle on which the displayed registration plate was not valid for the current registration period, a penalty assessment misdemeanor, contrary to NMSA 1978, Section 66-3-18 (2018).

THIS MATTER came before the Court on December 6, 2021, in consideration of Defendant's conditions of release. The State was represented by Taylor Jagers. The Defendant, Jorge Armendariz, appeared by video-conference and was represented by Renee Broberg..

Being advised in the premises, the Court FINDS:

1. Defendant's conditions of release should be amended as set forth below.

Release on recognizance or unsecured bond:

It is ordered that the defendant be released from custody upon:

The court finds that release on non-monetary conditions alone will not reasonably assure the appearance of the defendant and protect the safety of any other person or the community. Based on the evidence presented, the Court sets bails as follows:

- have an ignition interlock device installed on any vehicle the defendant may drive; (camera capable ignition interlock device);
- be on pretrial supervision and abide by all conditions set by the court and by pretrial services;
- reside at 23 W. Wells, Roswell, NM unless otherwise agreed to by the court;
- submit to drug or alcohol testing upon the request of _____;
- not leave the defendant's residence between the hours of 8p.m. and 6:30 a.m. without prior permission of the court;
- maintain employment, or, if unemployed, actively seek employment;
- maintain or commence an educational program;

- not associate with any person engaged in illegal activity;
- appear at all hearings in this matter;
- Prior to or at the time of release from custody, Defendant shall arrange to have a SCRAM monitor installed. To do so, Defendant shall contact Jarred Cobb at Southwest Monitoring, (Cell: 505-264-4525; Office: 866-952-6639, or jcobb@southwestmonitoring.com) to have an ankle monitor installed by Southwest Monitoring. The Defendant shall be responsible for all costs of the monitor. Confirmation of the installation of the monitor and any reports of events or failures shall be provided by email from Southwest Monitoring to the District Attorney's Office. Any of the following events shall be a basis to issue a warrant for the Defendant's arrest to review conditions of release: (i) the failure to have the ankle monitor timely installed; (ii) the failure to maintain the ankle monitor in operating condition; (iii) an attempt to disable or remove the ankle monitor; (iv) failure to pay for the monitor so that it is cancelled; (v) a positive indication for consumption of alcohol; or (vi) a report showing that the Defendant is outside the jurisdiction or is in a place prohibited by the conditions of release;
